Wait list applications must be renewed in February of each year along with the \$10.00 fee. Failure to renew will result in removal from the wait list.

1. Marina slip or river mooring assignments will be made by the Dockmaster on or about April 1st. **Acceptance of assignment must be made within 48 hours.** Slip / mooring fees are due immediately upon assignment. Applicants must present a current Connecticut Boat Registration, current insurance policy with minimum \$300,000 liability coverage before their vessel may be put in the Marina property.
2. A wait list applicant who rejects a marina slip or river mooring assignment will be allowed to maintain their current priority on the list for one year. If after one year, the applicant again rejects a spot assignment, the applicant will be removed from the list and will forfeit fees already paid. An applicant who is assigned a spot after May 1 may refuse it without penalty.
3. The cost of a marina slip or river mooring assigned after May 1 will be prorated for the time the spot will be available.
4. Marina slip assignment for vessels assigned to a slip for the first time after becoming eligible from the wait list are not final until the Dockmaster has measured the vessel and verified that it is suitable for the slip assigned. Vessel owners are required to contact the Dockmaster as soon as the vessel is berthed for the first time. **** NOTE: Should the Dock master determine the vessel size is not appropriate for the slip, the vessel will have to be removed and the applicant required to re-apply via the appropriate wait list.**
5. Applicants are urged to become familiar with the "Guilford Marina Rules and Regulations". A copy can be obtained from the Dockmaster, the Town Clerk at Town Hall or from the Guilford Town Marina web site: <http://www.GuilfordTownMarina.com>
