The current licenses for Northern Heights - 3 B Ranch (Andrew Bazzuto) submitted bid of \$75.00 and therefor did not receive a new license.

K. Magee stated that the East River Preserve property is reserved for wildlife. The fields are cut yearly in August.

Farm Issues – Csmr. K. Brockett stated that there are some Board of Assessments issues related to farming. The commission needs more information from the Farm Bureau to assist with definition of farm buildings.
