1. Update from Town Engineer Janice Plaziak

Janice spoke on the round of sidewalks that were replaced in town and completed. She also said the new handicapped ramps have been installed on Whitman and Water Streets, but haven't been striped yet and is still waiting feedback from DOT for the removal of the other handicapped ramp. Janice said she is pricing out sidewalk replacement for the connection between Guilford Court and Church Street as well as replacing some of the old asphalt sidewalk that was left in front of the high school.

There is potential to approach a sponsor to have more printed. Melissa has asked one and they have declined, so if anyone else knows of potential sponsors and would like to approach, that would be appreciated. Jim Bussmann said that he will talk to Zane's. Sam Gerritz suggested that it might be time to reach at to Jesse at the Courier to talk to Tom about the design and Melissa said she will contact him.
